

SUSPENSION OF STANDING ORDERS

It was **Moved** Councillor Borg, **Seconded** Councillor Lound that City Works Item 1.3 - Campbelltown Road Upgrade and Community Services Item 6.1 - Campbelltown Road Upgrade be brought forward and dealt with in conjunction with each other at this stage of the meeting.

1 The Motion on being Put was **CARRIED**.

Having declared an interest in regard to City Works Item 1.3 and Community Services Item 6.1, Councillor Chanthivong left the Chamber and did not take part in debate nor vote on these items.

Campbelltown Road Upgrade

It was **Moved** Councillor Lake, **Seconded** Councillor Brticevic that

1. That Council make a submission to the Roads and Maritime Services and the NSW Premier strongly objecting to the planned intention to remove over 37 metres of curtilage from Denham Court House on Campbelltown Road, as part of the planned road widening works.
2. That Council strongly object to the removal of curtilage of the Ingleburn Military Heritage Precinct, specifically in front of the Mont St Quentin Oval and the Bardia Barracks site.
3. That Council inspect the site as a matter of urgency at a future briefing evening as appropriate.
4. That Council facilitate a community consultation meeting and extend an invitation to Roads and Maritime Services to be part of the consultation.
5. That Council write to the appropriate local State Members and the Minister for Roads expressing Council's concerns regarding the Campbelltown Road widening and requesting for a submission extension to 30 June 2013.

An **Amendment** in regard to Item 1.3 - Campbelltown Road Upgrade was **Moved** Councillor Borg **Seconded** Councillor Lound:

1. That Council make a submission to the Roads and Maritime Services (RMS) and the NSW Premier strongly objecting to the planned intention to remove over 37 metres of curtilage from Denham Court House and other properties on Campbelltown Road, as part of the planned road widening works.
2. That Council strongly object to the removal of curtilage of the Ingleburn Military Heritage Precinct, specifically in front of the Mont St Quentin Oval and the Bardia Barracks site.
3. That Council inspect the site as a matter of urgency at a future briefing evening as appropriate and that a representative from the RMS be invited to attend to address Councillors.

4. That Council facilitate a community consultation meeting and extend an invitation to Roads and Maritime Services and Liverpool City Council to be part of the consultation.
5. That Council write to the appropriate local State Members and the Minister for Roads seeking their support regarding Council's concerns with the Campbelltown Road widening and requesting for a submission extension to 30 June 2013.
6. That Council request that the RMS abandon the current Review of the Environmental Factors (REF) and undertake a new REF study seeking a wider public input into the process.
7. That Council is strenuously opposed to the movement of the milestones which exist along Campbelltown Road in particular the one that is located in the area previously known as Ingleburn Army Camp.
8. That the Mayor and the General Manager make an urgent request to have a meeting with the Minister for Roads and report back to Council as soon as possible.

WON and became the Motion.
